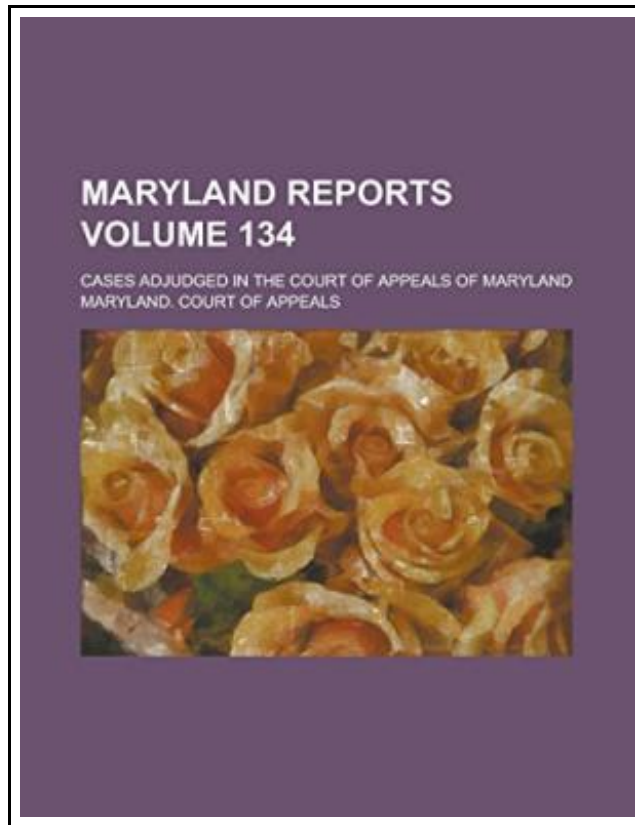

On demand after date, I promise to pay to the order of Isaac E. Emerson four thousand dollars and have deposited as collateral forty shares of Maryland Glass Corporation stock. J. H. Williams. At the same time he endorsed...
